**CONTINUATION ORDER**

WHEREAS, the recognition was granted to the institution namely, S.R.M. College of Education, No. 85, Trunk Road, Valayampattu, Vaniyambadi – 635751, Vellore District, Tamilnadu vide SRC (NCTE) order no. F.TN/SEC/SRO/NCTE/2005-2006/5949 dated 28.04.2006 for Secondary (B.Ed.) course of one-year duration from the academic session 2005-2006 with an annual intake of 100 students.

2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the Institution is submitted affidavit dated 20.01.2015 & for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 31.05.2015 for conducting B.Ed. programme of two years duration with an annual intake of 100 students (two basic units) from the academic session 2015-16.

3. AND WHEREAS, the SRC in its 388<sup>th</sup> meeting held on 14<sup>th</sup> – 15<sup>th</sup> September, 2020 considered the matter and decided to issue SCN/FSCN in all RPRO cases asking them to submit all the required documents as per the 13 points. Accordingly, as per the decision of SRC Show Cause Notice was issued to the institution on 08.06.2021. The Institution vide letter dated 25.06.2021 submitted reply to the Show Cause Notice.

4. AND WHEREAS, the SRC in its 401<sup>st</sup> meeting held on 11<sup>th</sup> – 12<sup>th</sup> August, 2021 considered the matter and decided as under:-

*"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-*

*The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution S.R.M College of Education, Survey No. 36/2, Chinnakallupalli Village, Kalandra Post, Vaniyambadi, Vellore District, Tamilnadu-635751 for B.Ed. programme for 2 basic units of 50 students each."*

5. NOW THEREFORE, this order is issued permitting the institution i.e. S.R.M College of Education, Survey No. 36/2, Chinnakallupalli Village, Kalandra Post, Vaniyambadi, Vellore District, Tamilnadu-635751 for Continuation of recognition for B.Ed. programme for two year duration with annual intake of (2 basic units) of 50 students each subject to fulfillment of the following conditions:

Audit Report

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

6. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.

7. The institution shall submit to the Regional Committee as Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

8. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:-

- a. Sanctioned programme(s) along with annual intake in the institution;
- b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c. Name of faculty members who left or joined during the last quarter;
- d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e. Fee charged from students;
- f. Available infrastructural facilities;
- g. Facilities added during the last quarter;
- h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i. The affidavit with enclosure submitted along with application.
- j. The institution shall be free to post additional relevant information if it so desires.
- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.


9. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

10. The institution shall make available the list of students admitted on its official website.
11. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued there under, the Institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provision of Section 17(1) of the NCTE Act, 1993.


